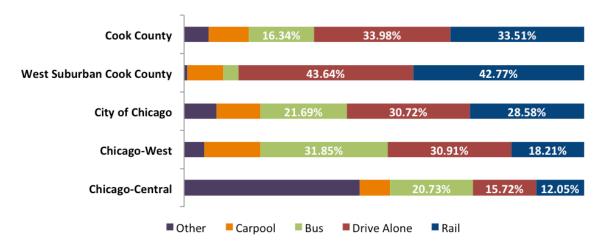
Additional Federal Funding Needed for Repair & Replacement
